On October 20, 2025, the Court granted Plaintiffs' Motion for Final Approval of the Settlement with MarinHealth Medical Center. On November 18, 2025, the Court granted Plaintiffs' Motion for Award of Attorneys' Fees and Expenses and Plaintiffs' Service Payments. Class Counsel is hereby awarded \$860,543.25 in attorneys' fees, \$23,825.43 in costs and expenses, and Plaintiffs are granted service payments in the amount of \$2,000 each, for a total of \$6,000. Attached hereto as **Exhibit A** is a true and correct copy of the Court's Order Granting Plaintiffs' Motion for Award of Attorneys' Fees and Expenses.

The Court hereby enters final judgment in this case in accordance with the terms of the Settlement, Amended Final Approval Order, Order Granting Plaintiffs' Motion for Attorneys' Fees and Expenses, and this Judgment.

Without affecting the finality of the Settlement or Judgment entered, this Court shall retain exclusive and continuing jurisdiction over the action and the Parties, including all Settlement Class Members, for purposes of enforcing and interpreting this Order and the Settlement.

## Exhibit A

Doe, et al., v. Marin Health Medical Center Case No. CV0002218


On October 27, 2025, the Court tentatively approved Class Counsel's request for attorneys' fees and expenses, awarding \$708,925 in fees and \$22,033.81 in expenses. The Court subsequently entered its Final Approval Order on October 28, 2025, and authorized Class Counsel to supplement their submission to include additional fees and expenses incurred after filing the Motion for Attorneys' Fees, Expenses and Service Payments ("Motion for Fees").

On November 3, 2025, Class Counsel submitted a Supplemental Declaration detailing their additional fees and expenses. Having considered the Motion for Fees, supporting declarations and exhibits, the Supplemental Declaration, counsel's arguments, and any objections, and good cause appearing, the Court orders as follows:

- 1. **Attorneys' Fees:** Class Counsel is awarded attorneys' fees of \$\frac{1}{1} \overline{\mathbb{H}} \overline{\mathbb{I}} \overline{\mathbb{H}}, in total, consisting of \$708,925 previously approved in the October 27, 2025, tentative order, and \$\frac{\mathbb{F}}{\mathbb{H}} \overline{\mathbb{H}} \overline
- 2. **Expenses and Costs:** Class Counsel is awarded total expenses of \$ GHÊ GÉ H, consisting of \$22,033.81 previously approved in the October 27, 2025, tentative order, and \$ FHÊ JFÊ C incurred on or after August 4, 2025.
- 3. The previously entered Final Approval Order of October 28, 2025, remains in full force and effect.
- 4. The awarded fees and expenses shall be paid by the Settlement Administrator pursuant to the terms of settlement.
